Emergency Pool Operation and Use Rules in Response to Covid-19  
Adopted May 12, 2020

Greer Ranch Community Association makes no representation as to the sanitization or disinfected condition of the pool or any part of the pool area. Greer Ranch Community Association has made every effort to ensure that the pool and pool area is sanitized, but can make no guarantees that the pool and pool area are clear of Covid-19. Use of the pool or pool area is strictly at your own risk.

These Pool Operation and Use Rules are specifically in Response to Covid-19 and are in addition to the Pool Rules currently in effect.

1. To aid in observing appropriate social distancing, pool use shall be restricted to Greer Ranch Community Association residents only.
2. To aid in monitoring of pool operation/use during the Covid-19 epidemic, pool use hours are revised to 10:00 am to 6:00 pm, Sunday through Saturday.
3. Maximum occupancy will be limited to 30 persons at one time. Pool use may have to be scheduled in 2 hour use increments to allow as many residents as possible to have the opportunity to swim each day.
4. To facilitate appropriate social distancing the wading pool and spa will not be open for use.
5. No large groups or pool parties will be allowed. Residents of the same household may swim together.
6. Pursuant to Riverside County Department of Environmental Health, residents are strongly recommended to wear a cloth face covering when traveling through the common areas of the pool area where it may not be possible to maintain appropriate social distancing (to include but not limited to entering pool area, to and from the pool and to and from (and in) the pool restrooms).
7. Use of pool toys of any time (to include but not limited to squirt toys and balls) are prohibited. No objects are allowed to be thrown at any time within the pool or pool facility area.
8. Use of flotation devices (to include but not limited to rafts, boogie boards, inflatable flotation devices) other than those specifically designated to provide assistance in swimming are prohibited. The use of pool noodles as a swimming assistance device is acceptable so long as they do not pose a nuisance to others. Exceptions may be made for those with disabilities.
9. To facilitate in observing appropriate social distancing, use of Association pool furniture is restricted, however residents may bring their own pool/beach chairs (only) to sit on.
10. Residents are required to bring their own hand sanitizer.
11. To aid in observing appropriate social distancing, a minimum of six feet (6') distance from other swimmers must be maintained at all times. Residents of the same household may swim together. A minimum of six feet (6') must be maintained outside the pool as well.
12. Use of Barbecues in the pool area is restricted.
13. Pool use is restricted to those experiencing symptoms of illness including a fever of 100° or above, sore throat, runny nose, chills, not feeling well, sneezing, coughing, abdominal pain or diarrhea.
